The Registered Restaurant Apprenticeship Program connects people to the nation's second-largest private-sector employer — restaurants — through industry apprenticeships in several disciplines. Apprentices gain valuable on-the-job training while earning a U.S. Department of Labor-approved industry certification. The National Restaurant Association Educational Foundation funds the apprenticeship-related training expenses, so there is no cost to the business or the apprentice.

APPRENTICESHIP TRACKS

All tracks are available to individuals 17 or older applying for a first-time position **OR** to any of your current employees who show potential!

- LINE COOK (12 months)
- KITCHEN MANAGER (18 months)
- RESTAURANT MANAGER (24 months)

ADVANTAGES OF PARTICIPATING

- No cost to employer or apprentice
- Candidates who may have already completed ProStart or other in-classroom training & come equipped with technical skills
- Improves retention rates
- Builds diverse, engaged, and competent staff
- Can attract more job applicants as it enhances your benefits package

PROGRAM REQUIREMENTS

- Commit to training your apprentice for as long as it takes for them to gain the needed competencies.
- Provide at least one wage increase during their tenure.
- Provide on-the-job training in culinary skills, safety & sanitation, and management & leadership.*
- Training course component is provided by the NRAEF or community partner.

*Customized technical assistance is offered to help you and your staff prepare to support apprentices.

- **\$75** Complete the exploration course
- \$50 Meet with PRLAEF about the apprenticeship application process
- **\$50 –** Complete first interview
- **\$50** Complete apprenticeship registration
- **\$75** Complete first 90 days of the apprenticeship training

EDUCATOR SUPPORT

- **\$160** Per youth enrolled to pay for credentials
- **\$75** Per youth enrolled to pay for classroom training supplies
